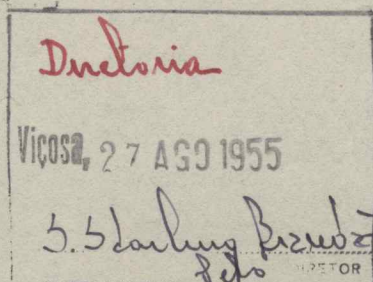

I am happy to inform you that the fellowship for Mr. Otto Andersen has been renewed for a period of twelve months, beginning approximately September 20, 1955, with a stipend of \$200 per month, a monthly family allowance of \$100, provided his wife remains with him in the United States, and provision for authorized fees, tuition, and expenses of travel, including the return travel of his wife to Brazil.
